

Air Services Bon Bons Candy Basket Giveaway – Official Rules

The **Air Services Bon Bons Candy Basket Giveaway** (the "Giveaway") is intended for legal residents of the state of **Missouri** who are homeowners within the **Air Services service area** and shall only be construed and evaluated according to applicable **USA law and Missouri state law**. ELIGIBILITY

The Giveaway is open to legal residents of **Missouri** who are **homeowners within the Air Services service area** and at least **eighteen (18) years of age** at the time of entry. Non-eligibility or non-compliance with any of these Official Rules will result in disqualification. Void where prohibited or restricted by law.
